- Explains the history and where they are headed.
- 1983 started. 23 clubs, just under 9000 players. Refs separate but good relationship.
- My role came about that we had volunteers, we put in admin. Did inv, mailing.
 Ect. Communication. Then we introduced a player levy for a General Manager.
 We now have a GM, PA & Comp Sec (couple of days a week) & director of coaching
- GMs role local council 3 LGAs, Networking, sponsorship, attending FNSW meetings,
- Q- Comp Sec's Role her role looking after clubs, teams and draw,
- 23 clubs 720 games every weekend.
- Q How do Non comp games run- they travel, but split up between North, South & West.
- Q Pros & Cons of out of towner to insider (GM position) he became involved at club level. And moved through ranks. Lots of contacts. Initial networking ahead of others. We had someone from outside, just did what he had to do and then moved on
- Q- when u started, how did you start it? Started a few days a week (Admin person). Letter and minutes for meetings, Basic clerical admin
- When u got sponsorship does it compensate for employees? No.
- Tres work to a budget, sets outgoing rego, he comes in weekly and watches

- over it. Voluntary position and is on the board of directors.
- Q-How much is the levy \$15.00 to start with? Manly building fund \$20.00 per player. Macarthur have always charged more on other fees and this is how they started with admin without levy
- Q Your structure of how u hire. Employed by board of directors, they run me. They give him set figures they he has to achieve, attached to bonus (sponsorship) he is answerable to board.
- Q Expertise. legal advice downloaded. From internet. he used to do sponsorship but the league club does this for them, they take a percentage.
- Q- Rams is part of us 24th club. Board is over them
- Q- council relationships how does it work. More beneficial to have staff, we can visit council whenever they ask, at any time of day.
