2.2 Referees Report:

- We as Referees are going to be having a more robust approach to language. I
 have had feedback from Referees; the zero tolerance approach is not getting
 through to teams. Refs will not do allot different to previous years, but we will
 be implementing this.
 - If people stub toe, and not super vocal then you may get warning, but we know the language on the park is not good.
 - You have been educated so you have plenty of notice to get a handle on what is happening. All PL squads should know.
 - I have the referee's language policy here for you to take back to your clubs.
 - Both BDAFA and Refs on same page this year.
 - PRSL our teams have not been assembled yet we have not had time to talk to them.
 - Referees are quiet happy to come out to clubs and talk about what we are about. We are not there to do anecdotal stuff; we can clarify laws of the games for you. Send requests through to association.
 - Q- Any new rules or interpretation not that u need to worry about. Just cosmetic
 - Q –looking through ref's rules skins same colour, will this be enforced?
 That is up to BDAFA if they would like to make allowance for black as it is more predominate. BDAFA to clarify
 - Q Fees set this year. This comes from FNSW Leanne P will send back through to clubs.
 - Q More refs than last year We are also doing our rego online there have been issues, 70 registered so far. 28 going through course up stairs. We usually get about 130. Of the 28 doing the course we have 5 seniors.
 - We won't withdraw services to anybody.
 - We have a very good working relationship with Association, we have developed the MOU and we are working on the same page.
 - Refs are worried about what's on the park, we are half of the equation the clubs are the other half it is back to the clubs to have their ground marshal around. Clubs can't expect kid refs to control crowds and spectators.

 - R the canteen takings going back to the clubs that will be down numbers like us or Panania? We will loose volunteers to club. As the volunteers will not be connected to the club. In 10-15 years will they be.
 - I think as courtesy to club we should have a P & S.
- Milperra –You cannot expect parents to identify with the club if they are not there.
- Strikers You are asking parents that are new, ask parents that have an idea about how the draw used to be like.
- St Chris we had our meeting revenue problem, relationship with families.

- Thistles- with the hub system we would have canteen takings that we would also have people at our field. It would benefit our club.
