5.5 Senior Vice Presidents Report:

If anything longer than a one-match suspension, player cards MUST be submitted to BDAFA Office prior to next game for that team, or that team will forfeit. (By-law 20.7)

- Several Clubs have engaged in the self-discipline process this season and have in some cases handed down significant suspensions to their members. The Tribunal encourages Clubs to take responsibility for their members' discipline and, if sentences are commensurate with reported misconduct, will usually approve the suspension. Rules for cards and suspension served forms will still apply, and penalties MUST fall within the ranges for the offences in By-law 26.14, but ultimately that process saves everyone a lot of time and effort. This is for Incident Reports, not for red card offences which are still dealt with by DC.
- Remind all teams about By-law 17.1 (b) it is not the responsibility of the home team to provide an unofficial referee if an official is not appointed. Both teams must

agree on the one person who will referee the entire match. That person should have an understanding of the Laws of the Game, and if they feel they cannot be unbiased they should not start the match. The MC will not entertain complaints about unofficial referees unless it can be proved they were cheating. Having unofficial referees is also NOT an excuse for bad behaviour.

- Website traffic for May was just under 170K. Already over 15K for June.
- Team Vacancies page has now been removed because our registration window has closed, thank you to those Clubs who made use of it.
 - Q Preferable that you don't have someone personally affiliate with team.
 - Q CP regarding sent off player. Where do we find out how long DC will look at and pub. With the cards, team to give to club sec and then to BDAFA. When the suspension is served, form is to be in on Monday, then that gives us enough time for us to cross check.
